IMPORTANT: This is a pressurised container treat with caution.

PREPARATION

- Surfaces must be sound, stable, clean and free from contaminants such as dust, oil, grease and any loose material. Wear protection glasses and gloves, hold ready foam cleaner.
- 2. Screw gun to can adaptor. Shake well. (20-30 times)
- 3. Turn can upside down and press trigger.

APPLICATION

- 4. Only use in temperatures from +5°c to 35°c.
- 5. We recommend that whilst fixing boards , the plasterboard adhesive foam is applied onto the substrate in vertical strips at intervals of 30cm, Wait 5-10 minutes after application before pushing the board firmly into place.

CLEANING

- Uncured product may be removed using EVO-STIK Foam Cleaner..
- Cured product can only be removed by mechanical means.
