USES

EVO-STIK Rapid Mitre Fix is a special 'Super Glue' with an activator to ensure that it is rapid setting. It has been designed primarily for bonding the mitre joints of picture frames; however it will bond many other surfaces.

EVO-STIK Rapid Mitre Fix is designed to bond picture-frame mitre joints. However, it is suitable for bonding porcelain, many rubbers, most common metals, some types of jewellery and most plastics. EVO-STIK Rapid Mitre Fix has a higher viscosity than most 'superglues' and this in conjunction withits fast setting allows it to be used to bond porous materials, such as wood.

However, like most adhesives EVO-STIK Rapid Mitre Fix will not bond polyethylene (Polythene) or polypropylene. EVO-STIK Rapid Mitre Fix forms a very hard bond and is unsuitable for bonding soft fabric, card and paper, and other thin flexible materials. It is not intended for repairing containers that hold hot liquids and it should not be used near bitumen.

DIRECTIONS FOR USE

PREPARATION

- 1. Work on a protected surface in a well-ventilated area.
- 2. Make sure all surfaces to be bonded are close fitting, clean and dry.

APPLICATION

- 3. Remove the cap from the bottle of adhesive: on first use cut off the plastic seal on top of the nozzle.
- 4. Apply a single drop of the adhesive to one surface.
- 5. Shake the activator can well, and then lightly spray the other surface, in a well-ventilated area.
- 6. Bring the two together within 30 seconds and press firmly for about 10 seconds.

CLEANING

- EVO-STIK Rapid Mitre Fix has good resistance to most oils and solvents and can be very difficult to remove.
- 8. EVO-STIK Rapid Mitre Fix bonds to skin very quickly and easily. Should this happen, please do not panic. Do not attempt to pull apart as this may damage the skin. If left the bond will loosen within 60 minutes without doing anything. Hot soapy water and gentle peeling will part the bond; this can take up to 10 minutes, please be patient.
- Acetone will very slowly soften set super glue. Before attempting its use check that it is safe to use a highly flammable solvent and that the surfaces to which the super glue is adhered are not damaged by the solvent.
- 10. Always test before using any solvent.
